# **BUENA SENIOR MEN'S GOLF CLUB Board Meeting Minutes - October 22, 2024**

Meeting was called to order by President Mike Truex at 1:30 p.m.

Minutes from previous board meeting (November 28, 2023) were reviewed and approved by email.

### **Financial Report (Larry Mueller)**

As of September 30, 2024 the Club has net balance of \$8,506 in treasury.

#### Status of Buena Golf Course (Mike Truex)

Mike spoke at a recent Ventura City council meeting and emphasized the need for 18 holes at Buena, nothing less. The city is waiting for FEMA funding which appears to be delayed because of the recent hurricanes in Florida. The city has awarded a contract to study options for the Buena restoration. These options will most likely include less than 18 holes. The city created a Golf Advisitory Committee but has not invited any BSMGC board members.

### Slow Play (Mike Truex)

Mike stated that much improvement has been made with slow play.

### **Rules of Golf (Mike Truex)**

Mike suggested that board members should keep an eye on other members to ensure that all members are playing by the rules.

### Eliminate Historian from Board of Directors (Mike Truex, Pat Collins, Bob Murtha)

Pat Collins stated that the Golf Genius software can be used to compile quarterly summaries and year-end results of our tournaments. These Historian duties can thus be shifted to the duties of the Webmaster.

After some discussion the board unanimously approved a motion to eliminate the Historian position from the Board of Directors. (Aye = 9, No = 0)

## October 29th Texas Scramble Tournament, Lunch, General Meeting, & Election (Mike Truex)

On October 29<sup>th</sup> the club will hold a "Your Team" 4-Man Shotgun (800 am start) Scramble Tournament. Cost equals \$10 (\$5 for tournament prizes and \$5 for lunch) plus an optional \$1 fee for the HIO contest. Don Dickey, Mike Dovgin, and Chuck Spence will man the check-in table and collect the \$10 fee and have the envelopes available for the optional \$1 HIO contest.
