OLD BUSINESS

1. **M/S/P** (Majority Vote) HIO overflow value was raised to \$1000 from \$500.
2. Quadruple bogie rule to remain in place.

NEW BUSINESS

1. We will try to outline the greens pending Phil's approval, otherwise the automatic two putt distance shall be 8 paces from the pin for both #2 and #8.
2. **M/S/P** (Majority Vote) Hole #7 will have a closest to the pin prize of \$5. In the case where is no winner, the prize will go back into the prize pool for the day.
3. New Tuesday Tournament rule – Failure to provide \$5 entry in envelope/collection box for any reason will disqualify player from that week's tournament. Player shall be responsible for posting their own score for that day.
4. **M/S/P** (Majority Vote) The Associate Membership Level is no longer available and will be eliminated (HOLD – pending review).
